- Perform annual risk assessment. This can be performed internally or by partnering with internal audit or a service provider
- Assess materiality thresholds and accounts
- Update business processes for any changes
- Identify new controls for new processes
- Update risk control matrix

# 2 WALKTHROUGHS & DOCUMENTATION

- Participate in scheduled walkthroughs with auditors
- Provide support to parties updating documention (e.g. narratives, flowcharts, etc.)
- Evaluate segregation of duties (SOD) and identify compensating controls

# TEST OF DESIGN

- Respond to requests from internal and external auditors for a 'Sample of One' supporting evidence
- Respond to follow ups for test of design
- Create Management Action Plan for logged issues or exceptions with assistance from internal audit



#### **TEST OF OPERATING EFFECTIVENESS**

- Respond to population requests from internal and external auditors
- Respond to sample requests
- Respond to follow ups for test of operating effectiveness
- Create Management Action Plan for logged issues or exceptions



#### REMEDIATION

- Verify issue log for outstanding issues
- Approve remediation plans
- Implement remediation measures



#### **CONCLUSION & EVALUATION**

- Re-evaluate risk assessment and compare to Phase 1
- Review presentation of results and findings with your internal audit provider
- Review results and key findings with Audit Committee
